Description

Giltgrip 60 is a polyurethane based general purpose adhesive ideal for bonding carpet gripper, woods, metal trims, metal nosing, aluminium and many other types of products where a quick bond is required to concrete, timber and most other common building substrates.

Scope of use

for bonding carpet gripper, woods, metal trims, metal nosing, aluminium & many other types of products where a quick bond is required to concrete, timber and most other common building substrates.

Conditions of use

All surfaces must be clean & sound, free of dust and any other contaminants that may affect bond. Apply thin bead of adhesive to one surface. Press the two surfaces to be bonded firmly together. Pressure may need to be applied to keep the two surfaces in contact while adhesive cures. Large extrusions should also be secured with appropriate fixing screws. Giltgrip 60 is a moisture cure system. Allow approx. One hour curing time. This process may be accelerated by spraying a light mist of water to one of the surfaces. Thick beads will take longer to cure and will

have a weaker bond than a thinner bead. The thicker the bead of GG60 the more the product will tend to foam.
