

# GiltGrip 66 Pressure Sensitive Adhesive

### Declaration

Gilt Edge Industries has provided this declaration to satisfy the provisions of Schedule 1(d) of the Building (Building Product Information Requirements) Regulations 2022.

### Product/system

<b>Name</b>	GiltGrip 66 Pressure Sensitive Adhesive
<b>Line</b>	Acrylic emulsion
<b>Identifier</b>	GG66

### Description

Giltgrip 66 Pressure Sensitive adhesive is Low in VOC and has been developed for the installation of vinyl composition tiles. It is also suitable for the installation of Carpet Tiles and slab underlays used in the double bond carpet installation. It has good plasticizer resistance.

### Scope of use

Carpet Tile floor coverings. carpet underlay in double bond carpet installations.

### Conditions of use

To be in accordance with The Australian/NZ Standard 1884 "Floor Coverings – Resilient Sheet and Tiles – Laying and Maintenance Practices" & Australian/NZ 2455:1:2007 Textile Floor Coverings. All surfaces to be bonded shall be dry, smooth, sound and clean. Subfloors must also be free of wax, grease and hydrostatic pressure. The minimum subfloor temperature before commencing surface preparation and adhesive applications 10 degrees C. Highly absorbent wooden or concrete subfloor surfaces are to be primed with a suitable Acrylic Primer prior to the application of adhesive. All concrete substrate floors should be tested for moisture content, according to the above Australian/NZ Standard prior to undertaking surface priming or installation of floorcoverings. For the installation of composition tiles & textured backed double bond underlays,

apply adhesive using a 1.6mm x 1.6mm x 1.6mm “V” notched spreader with approx coverage of 5m<sup>2</sup> per litre. When installing Carpet Tiles and smooth backed Double Bond underlay, use a long nap roller with approx coverage of 7m<sup>2</sup> per litre. Store in dry, cool conditions away from direct sunlight.

Building Regulations 1992 - Clause 2B-Durability GiltGrip 66, with only normal maintenance, will continue to satisfy the performance requirements of Building Regulations for 15 years.
