Description

Nexus 485 Outdoor Grass Adhesive is a solvent based outdoor grass adhesive used for the installation of synthetic grass carpet in outdoor applications.

Scope of use

Adhesive for the installation of synthetic grass carpet in outdoor applications

Conditions of use

To be in accordance with the current Australian/NZ Standard 1884 -2013 "Floor Coverings – Resilient Sheet and Tiles – Laying and Maintenance Practices". The surface should be clean, dry, absorbent, and free from dust, grease, oil, and contaminants that may affect final bond. Concrete must be cured and free of any curing compounds. Spread the adhesive with the recommended "V3" 3.2mm x 1.6mm x 3.2mm notched trowel. For coarse backed grass, a larger trowel up to 6 mm may be required to ensure that a transfer rate of at least 80% is achieved. Allow a short time to tack-up before placing carpet into wet adhesive.
