Scope of use

All phases so the installation must comply with AS / NZ Standard 1884-2013 – Floorcoverings – Resilient Sheet & Tiles - Installation Practices" and AS/NZ Standard 2455.1:2007 – "Textile Floor Coverings Installation Practice". The surface must be clean, structurally sound, dry, permanently dry, and free from all contaminants which will inhibit good adhesion – this includes old adhesives, floorcoverings, polishes, paint, Concrete curing agents and laitance. When adhering to highly absorbent surfaces, the use so polymer 6000 Primer is strongly recommended.

Conditions of use

APPLICATION: Select the correct trowel as determined by the material to be adhered and the substrate

condition. Normal recommendation is 1.0 - 1.5mm V notched trowel.

CARPET TILES AND DOUBLE-BOND UNDERLAY: For a peelable bond, wait until the adhesive has dried completely clear before placing the material in position. For a stronger bond (but still peelable) the material may be placed into the adhesive whilst it is still wet or partially dry.

VINYL COMPOSITION TILES (VCT): Apply adhesive using a 1.0mm – 1.5mm V notch trowel (depending on condition so substrate) then immediately roll adhesive with a short nap roller to flatten trowel lines. When the adhesive has dried clear, the tiles can be placed into the adhesive. In all instances, roll the installation immediately with an appropriate floor roller and finish according to floorcovering manufacturers' instructions.

ADHESIVE DRYING TIME: This will depend on ambient temperatures, humidity, air flow and absorbency to the substrate. In ideal conditions the drying to clear time could be less than an hour, however if conditions are cold and/or wet, then drying time could be considerably extended.
