Description

Supporta Pad Underlay is a SBR rubber sponge underlay designed for Double bond installation in conjunction with modular carpet tiles. It is designed to provide protection and enhance the appearance of the tiles. It reduces pile distortion in low profile carpet modules with exhibiting a low deflection under vertical forces.

Scope of use

Giltgrip Supportapad is a latex rubber sponge underlay designed for double bond installation of carpet tiles. Suitable for use in heavy duty contract commercial

installation under carpet tiles to provide protection and enhance the appearance of the modules. It provides some level of additional comfort while exhibiting a low deflection under vertical forces.

Increases thermal insulation for reduced energy consumption and warmer rooms.

Improves Impact Insulation Class Ratings essential in reducing transference of noise.

Suitable for all floor types, including heated slabs.

Anti-microbial.

Recyclable.

Meets Australian Standard AS 4288-2003 for underlay durability.

Pressure sensitive adhesive (underlay to sub_oor adhesion option) for ease release up uplift in the future.

All system adhesives and primers are manufactured in Australasia from solvent free, water-based formulations and are certi_ed Low VOC and comply with NZ Green Star Adhesives /Sealants VOC limits.

Conditions of use

Important to follow GiltEdge 3 Step Total Flooring System Installation

1. **CONCRETE TREATMENT:** Concrete Slab Treated with Protect Crete X200 Densi-Proof (at time of pour) to cure, densify, protect and moisture control.
2. **SUPPORTAPAD GLUED TO SUBFLOOR:** Carpet Adhesive: Giltgrip 22 or Roberts 80or Pressure Sensitive Adhesive: Giltgrip 66 or Polymer 999.
3. **CARPET TILES GLUED TO SUPPORTAPAD** Pressure Sensitive Adhesive: Giltgrip 66 or Polymer 999 Or Carpet Adhesive (If required): Giltgrip 22 or Roberts 80

Contributions to compliance
